## NYC VCP Cleanup Plan Remedial Activities to Begin

The New York City Office of Environmental Remediation (OER) is providing this Fact Sheet pursuant to the New York City Voluntary Cleanup Program (VCP). OER has approved the Remedial Action Work Plan (RAWP) submitted by 37-10 Crescent Street, LLC for 37-10 Crescent Street, Queens, New York (Block 367, Lot 27). The remedial work has started. The RAWP can be reviewed electronically at the document repositories identified in the box to the left.

### Site Description:

The Site is 18,300 square feet and currently consists of a one-story warehouse used for parking and offices. The proposed future use of the Site will be a 7-story residential and manufacturing at grade level mixed-use building with a full cellar for parking.

### Summary of the Remedy:

The remedial action for 37-10 Crescent Street is a Track 1 Unrestricted Use cleanup. The specific elements of the proposed remedial action include:

- Preparation of a Community Protection Statement and performance of all required NYC VCP citizen participation activities according to an approved Citizen Participation Plan;
- Performance of a Community Air Monitoring Program for particulates and volatile organic carbon compounds;
- Selection of Track 1 Unrestricted Use Soil Cleanup Objectives (SCOs);
- Excavation and removal of soil/fill exceeding Track 1 Unrestricted Use SCOs. The entire footprint of the Site will be excavated 10-11 feet below grade for the new building's cellar level. Approximately 11,000 tons of soil will be excavated and removed from Site;
- Transportation and off-site disposal of all soil/fill material at permitted facilities in accordance with applicable laws and regulations for handling, transport and disposal of contaminated soil;
- Collection and analysis of endpoint samples to determine if the remedy meets SCOs; and
- Submission of a Remedial Action Report (RAR) that describes the remedial activities and certifies that the remedial requirements have been achieved and lists any changes from this RAWP.

If Track 1 Cleanup is not achieved, the following construction elements (as part of new development) implemented will constitute Engineering and Institutional Controls:

- As part of new development, installation and operation of a 60-mil vapor barrier system beneath the building slabs and along subsurface sidewalls;
- As part of new development, construction of a composite cover system consisting of the 5" thick concrete building slab to prevent human exposure to residual soil/fill remaining under the Site;
- As part of new development, construction and operation of a ventilated parking garage in the in accordance with NYC Building Code requirements;
- Submission of an approved Site Management Plan (SMP) in the RAR for long-term management of residual fill, including certification of Engineering and Institutional Controls and reporting at a specified frequency; and
- Continued registration with E designation for the property if Track 1 cleanup is not achieved.

Cleanup activities have started and are expected take approximately two months to complete.

**Next Steps:** After the enrollee completes the remedial work, a RAR will be prepared and submitted to OER. The RAR will describe the cleanup activities and certify that all cleanup requirements were met. Once the RAR is approved, OER will issue a Notice of Completion, a City liability release, and a New York City Green Property Certificate. OER will then issue a fact sheet announcing the completion of the remedial action and identify all engineering and institutional controls to be used at the Site.

Figure 1 – Site Location Map




Figure 2 – Site Map
